RE: PRIVATE PRACTICE LICENSE FEE WAIVER

KNDI Council and Management under the leadership of Chairperson (**Dr. Evayline Muthoni Nkirigacha**) and the CEO (**Dr David Okeyo**) wishes to inform all Nutritionists and Dieticians that went through one (1) year internship as follows:

- i. With effect from **1st May 2019**, all the professionals who were licensed having gone through internship in 2015, 2016, 2017 onwards, are advised to start Nutrition and Dietetics Clinics and Wellness Centers (NDWCs) either as Partners, Private Limited Companies, Public Limited Companies; CBO's, NGO's to offer nutrition consultative services to Kenyans in the spirit of access to quality nutrition services within UHC framework.
- ii. KNDI shall waive registration and license fee for a period of three years in operation.
- iii. All professionals intending to start clinics shall only register their business names with other various statutory bodies including NGO Board or Office of the registrar at AG's office (Partnerships and Limited Companies)
- iv. Professionals shall complete Business registration form (**RC5**)/Ref: KNDI/BUSINESS/FORM/003 indicating on the form '**waiver**'.
- v. Professionals are encouraged to form partnership which shall include at least three of the six specialties as follows:

- Clinical Nutritionists
- Clinical Dieticians
- Community Nutritionists
- Public Health Nutritionists
- Food science Nutritionists
- Food Diet Therapists

Note:

All professionals who express interest shall be technically advised by KNDI on the acceptable concept details, requirements and implementation.
